### 5. Sunrise Project Update - Presentation

Sunrise Regional Update – Mike Wood

MW provided the CCC with an update on the activities undertaken in the region since the April 2021 meeting:

- Electricity Transmission Line
  - o Connection agreement process is underway with network service providers
  - o Discussions ongoing with landholders along the proposed route
- Parkes Office
  - Office has been sub-let to Fulton Hogan, who are undertaking the civil and services infrastructure for the Parkes Special Activation Precinct
  - o Approximately 40 Fulton Hogan staff are utilising the office space
- Autoclave relocation
  - During October, our two autoclaves stored at Pt Pirie, South Australia were moved to a new storage location approximately 3km away
  - A number of infrastructure modifications (civil & electrical) were required along the route with learnings from this move relevant for the move to NSW
  - The autoclaves were moved using self-propelled modular transporters (i.e. no prime mover needed), which provided more manoeuvrability which reduced the extent of the civil works required for the move

- Exploration
  - Exploration activity on ML 1770 has included completion of the second phase of platinum drilling, with laboratory assay results still being received and reviewed
  - Exploration activities undertaken regionally included:
    - A 40 hole drilling campaign on EL 8833 targeting limestone
    - Diamond drilling currently underway on EL 4573
    - Access agreement discussions with landholders underway at the Hylea Project tenements, with exploration activity planned to commence in 2022
    - Locally based exploration team with local contractors and labour employed where possible

#### Q & A relating to Mike Wood's update

JM asked: Hasn't there been some drilling at Hylea previously?

**SR replied:** Yes, that's right. Drilling was undertaken on a 600m x 200m grid targeting mainly cobalt, located in the south-east portion of the Hylea tenements. Future drilling will target the 5km-long magnetic anomaly identified at Hylea during earlier geophysical surveys.

# Community Update – Bronwyn Flynn

BF provided the CCC with an update on community relations activities since the July 2021 meeting:

• Sunrise Energy Metals attended the NSW Minerals Council hosted Mining Careers Dinner held mid-year in Orange for year 10 students. The evening was well attended by both students and mining companies, and the Minerals Council is planning on hosting a similar event in Dubbo in 2022.

- Sunrise Energy Metals continues to support the Condobolin Public School's breakfast club.
- The next Sunrise Project newsletter will be published this month. Keep an eye out in the local paper in the lead up to Christmas. The newsletter will also be published on the website.
- No community complaints have been received so far this year.

# Environmental Management Update – Bronwyn Flynn

- Environmental monitoring at the Sunrise Project is continuing in line with the Project Development Consent and Environmental Protection Licence, including:
  - Dust (depositional and particulate matter monitoring)
  - Surface water (sampling events occurred in August and November)
  - Groundwater monitoring (sampled in October and November six monthly onsite and borefield monitoring)

## Environmental Approvals Update – Bronwyn Flynn

- A timeline was provided of the key milestones for the Project Execution Plan Modification since it was submitted in mid-2021.
- Ten agency/government submissions were received during the exhibition period.
- The Modification is currently under assessment with the NSW Department of Planning, Industry & Environment.

# NSW Government Critical Minerals Hub Announcement – Sam Riggall

SR provided some background to the NSW Government's recent announcement on a Critical Minerals Hub to be located near Dubbo:

- This is a welcome announcement for the region and many Projects in the area
- More detail around the announcement will probably come in the near future
- Although Western Australia has a developed critical minerals industry (such as lithium), they're not the only State that has minerals needed for the battery supply chains
- The State government's strategy for the Hub may also assist with programs to support training for skilled roles
- State and Local government policies, and timeliness of approvals, will play an important role in attracting overseas investment

# Funding Update – Sam Riggall

SR provided an update on funding for the Sunrise Project:

- There has been more activity on the finance front recently inward interest in the Project is very strong
- Nickel prices are at ten year highs, and cobalt prices are also relatively strong
- Regions that will depend on these metals include Japan and South Korea, with the US and Europe not far behind
- Sunrise Energy Metals will continue to focus on financing activities Sunrise becomes more valuable as the decarbonization trend accelerates
