

Sunrise Regional Update

Power Supply

- > 132kV supply is proposed from Transgrid's Parkes substation direct to Sunrise
- > Negotiations ongoing with landholders along the proposed 132kV Transmission Line between Parkes & Sunrise
- > Connection agreement process underway with Network service providers
- > 100% renewable energy supply with no impact on project NPV

Parkes Office

- > Parkes office sublease in place with Fulton Hogan with around 40 personnel utilising the office space
- Fulton Hogan are designing and constructing the civil and services infrastructure for the Parkes Special Activation Precinct



Sunrise Regional Update

Autoclaves Relocated

- The two autoclaves stored at Port Pirie in South Australia were recently moved to a new storage location nearby
- This involved permits and approvals with NHVR, road, rail and power authorities and the Port Pirie Regional Council
- A number of civil & electrical infrastructure modifications were required along the route with learnings from the short move applicable to the longer move to NSW

ML 1770 Phoenix Platinum Exploration

- > Phase 2 Diamond drilling completed at Phoenix on ML 1770
- > Assay results still being received and evaluated
- > Processing of existing magnetic data completed and additional target areas within ML 1770 being identified









Exploration in the Region

- > 40 hole reverse circulation drilling program completed on EL 8833 targeting limestone
- Hylea Project land holder meetings held and access agreement negotiations in progress with planning for a scout drilling program well advanced
- > Diamond drilling in progress on EL 4573 "Sunrise East"
- Exploration field work to commence across regional tenements following community consultation and land access agreement in 2022
- Locally based exploration team established with local contractors and labour employed when work is available

 - Air Quality
 - Surface Water
 - Groundwater
 - Meteorological
- > Depositional dust and Particulate Matter (PM₁₀ and PM_{2.5})
- > Surface water monitoring events
 - August, November 2021
- > Groundwater monitoring
 - October/November 2021
 - Next round scheduled for March 2022





Project Execution Plan Modification


Key Modification Milestones
