

Sunrise Regional Update








Sunrise Regional Update


- > Major Project Status awarded to SEM from the Federal Government (Dec 21) providing fast tracked approvals processes
- > Debt finance facility of \$400M announced from Export Finance Australia (Jan 22)
- > Testwork underway to include capability for lithium battery recycling and battery "precursor" production





Exploration in the Region – Sunrise East


- Diamond drilling completed on EL 4573 "Sunrise East" returned cobalt grades comparable to the Sunrise Project resource
- > Follow up 53 hole Reverse Circulation drilling program approved for Sunrise East commencing in March 2022 to test the extent of cobalt bearing oxide mineralisation





Exploration in the Region - Hylea

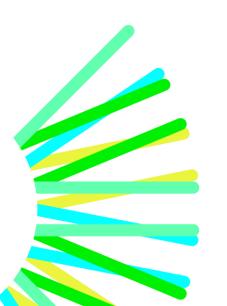
- > Hylea scout drilling program approved. Scheduled to commence Q2 2022
- > Exploration field work to commence across regional tenements following community consultation and land access agreements in 2022
- > Strong focus on locally based exploration roles


